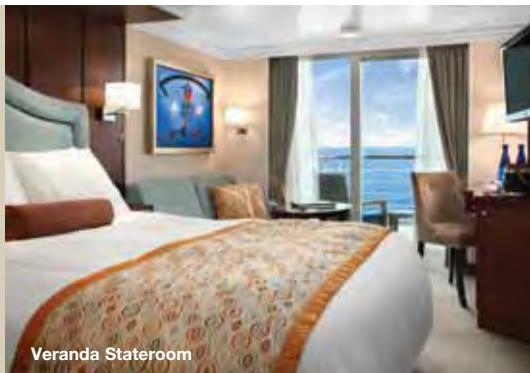

## PORTS OF CALL

**HELSINKI, FINLAND** See the city's historical buildings as well as its stunning modern architecture, and visit its lovely parks and open-air market. **BERLIN (WARNEMÜNDE), GERMANY** Enjoy a scenic drive to the German capital and savor landmarks like the Brandenburg Gate and the glorious Charlottenburg Palace. Stroll down Unter den Linden, see the site of the Berlin Wall, and take a boat ride along the city's canals. Explore on your own and visit one of the many museums.
