Ports of Call

GIBRALTAR, UNITED KINGDOM

Dominated by a huge mass of limestone rock, riddled with caves thought to be at least 135 million years old, Gibraltar has a fantastically varied history. Go to the top of the Rock and admire the view across the Mediterranean and up the peninsula into Spain. Visit the Gothic city of Requena featuring perfectly preserved, 100-year-old wine cellars. In Lladro's City of Porcelain museum, explore the production facilities, or visit the National Ceramics Museum located in the former palace of nobility.
