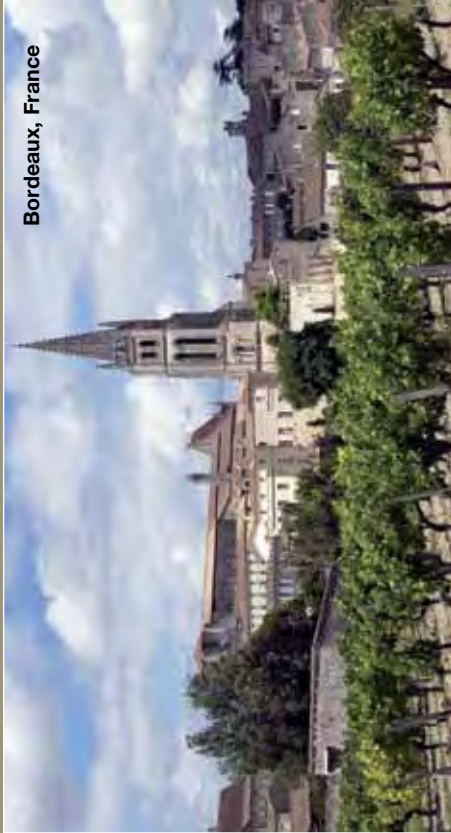
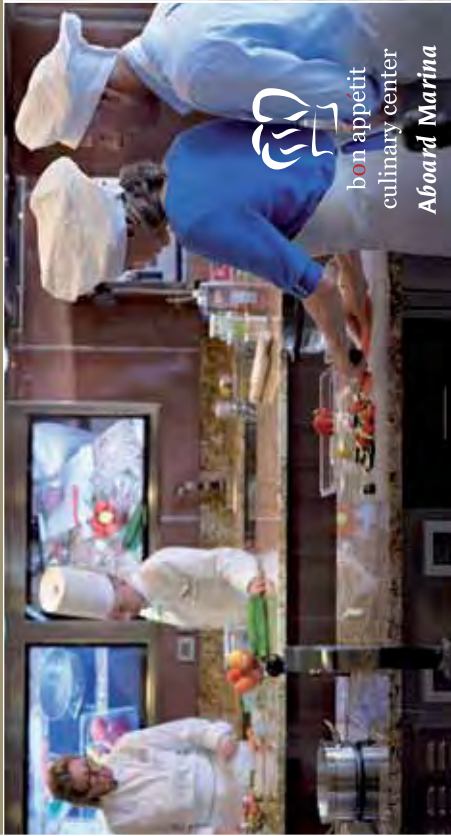

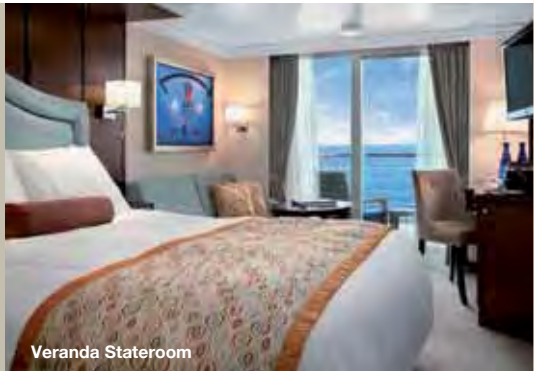

An artist's haven in the 1860s, the town still has a creative atmosphere as does nearby Pont-Aven, a vibrant and charming destination where Gauguin once had a studio. Or take a boat trip to the seabird sanctuaries of Iles des Glénan.

SAINT-MALO, FRANCE Saint-Malo is a walled port city in Brittany in northwestern France, built with the same grey granite stone as Mont St. Michel. It's the most visited place in Brittany, thanks to its superb citadel. Inside the stern and forbidding walls, the old city is busy and lively.
